



To: Parents and Guardians

Thank you for enrolling and encouraging your child in the economic education program JA BizTown. We will soon be visiting the JA BizTown facility to participate in the experiential simulation, where the students will put into work all they have learned in this amazing program. They have applied, interviewed and been assigned a Job!! Our on-site class Fieldtrip is scheduled for **Wednesday, February 26, 2014.**

We will have a school bus to transport the students to the JA Biz town facility in Mission Gorge, San Diego. For liability reasons, students **must** ride on the school bus. If you are a listed Parent Volunteer, you may drive your child back with you in your personal vehicle at the end of the fieldtrip day.

## Bus Route – Times and Locations

- **PALMQUIST** students, Arrive to your school at **8:00am**. Meet at the front of the school. Bus will promptly leave at **8:15am**. The bus will return to Palmquist at approximately 4:00pm, please pick up your child promptly. **\*\*Parent Volunteers** you may not drive your child to JA BizTown. After the fieldtrip, if you plan to drive your student home after the BizTown day concludes at 2:30, you **MUST** alert his/her BizTown Instructor that you are leaving BizTown with your child.
- **IVEY RANCH** students, Arrive to your school at **8:15am**. Meet at the front of the school. Bus will promptly leave at **8:30am**. The bus will return to Ivey Ranch at approximately 3:45pm, please pick up your child promptly. **\*\*Parent Volunteers** you may not drive your child to JA BizTown. After the fieldtrip, if you plan to drive your student home after the BizTown day concludes at 2:30, you **MUST** alert his/her BizTown Instructor that you are leaving BizTown with your child.
- **NICHOLS** students, Arrive to your school, at **8:20am**. Bus will promptly leave at **8:35am**. The bus will return to Nichols at approximately **3:40pm**, please pick up your child promptly **\*\*Parent Volunteers** you may not drive your child to JA BizTown. After the fieldtrip, if you plan to drive your student home after the BizTown day concludes at 2:30, you **MUST** alert his/her BizTown Instructor that you are leaving BizTown with your child.

**All Parent volunteers** that submitted the volunteer form **MUST** attend a mandatory training at the BizTown Offices beginning at **8:30 am at the Mission Gorge BizTown facility**. You may not drive your child to the BizTown facility; there is no supervision for them while you are in training. Only registered volunteers are allowed to attend; no other parents will be admitted into the BizTown facility. They have very strict rules about this. Please bring a lunch for yourself, there is no time or place to purchase lunch at BizTown.

**NO PARENTS ARE ALLOWED TO RIDE ON THE BUS. NO SIBLINGS ALLOWED AT JA BIZTOWN.**

**All children MUST bring a sack lunch** clearly marked with his/her name. Please do not send a drink as students will purchase them with their BizTown pay. **Due to food allergies, for the safety of all students, please avoid foods with peanut/nuts. Please notify your BizTown instructor if we need to be aware of an allergy.**

Students are video taped or photographed daily by the student Camera Operator working at JA BizTown and the Photographer for the JA BizTown Newspaper. The newspaper is an online newspaper where you can login and read articles about the day during your student's visit. The JA BizTown experience may also be photographed or videotaped by external media for use in communications and marketing materials.

**\*\*YOUR child going on the field trip MUST return the Parent Consent Form to their JA BizTown Instructor before the fieldtrip.**
